Documentation of Allergies/Reactions - Percentage of patients having documentation of allergies and adverse reactions in their medical record.

Appropriate Medications For People With Asthma - Patients 5 to 56 years of age with persistent asthma who were appropriately prescribed at least one asthma medication.

Avoidance of Antibiotic Treatment in Adults with Acute Bronchitis - Patients 18 to 64 years of age who were diagnosed with acute bronchitis and not prescribed an antibiotic.

LDL Drug Therapy - Percentage of patients with CAD who were prescribed a lipid-lowering therapy.

Current Medication List - Percentage of patients having a medication list on their medical record.

Warfarin Therapy for Patients with Atrial Fibrilation - Percentage of patients with atrial fibrilation who were perscribed warfarin therapy.
